All entries must adhere to current SWS Standing Rules (view on our website), including: Entries must be matted and completely enclosed in a frame, dry, and wired for hanging. No sawtooth hangers or unframes. Frames must be in good condition. Glass and mats must be clean. Archival materials must be used. No cardboard or masking tape allowed. Dust covers are optional but encouraged for wood and synthetic frames. Back must be clean and neat with no manufacturer’s labels or easel attachments.

*No framing supplies will be available on entry day.*

**FRAMED PAINTINGS**

**Two (2) maximum.**

**Minimum Size** – 16” x 20” or 20” x 20”, measured on outside edges of mat.

**Maximum Size** – Half Sheet matted and framed.

No Bin Art or Miniatures.

**Entry Fee: \$10**

Entrants **MUST** be current SWS members at least 30 days prior to entry day.

There will be no artist reception for this exhibit.
