<p align="center"><b>FRAMING</b></p> <p>Entries must be matted and completely enclosed in a frame, dry, and wired for hanging. No saw tooth hangers or unframes. Frames must be in good condition. Glass and mats must be clean. Archival materials must be used. No cardboard or masking tape allowed. Dust covers are optional but encouraged for wood and synthetic frames. Back must be clean and neat with no manufacturer’s labels or easel attachments.</p> <p>Paintings shown in 2 prior SWS exhibits in the past 24 months are ineligible.</p> <p>All entries <b>MUST</b> adhere to current SWS Standing Rules.</p>	<p align="center"><b>PAINTINGS</b></p> <p align="center">Two Maximum</p> <p align="center">Minimum Size – 12” x 16” on outside edge of mat</p> <p align="center">Maximum Size – Full sheets</p> <p>Full-sized paintings must use Plexiglas in lieu of glass.</p> <p><b>BIN ART: 4 Maximum.</b> Must be unframed, cleanly matted, backed and encased in appropriately-sized archival clear envelope (other wrappings are not acceptable).</p> <p>Art must be original, completed by the artist without supervision, at least 80% water media, executed in watercolor technique.</p>	<p align="center">Entry Fee: \$10</p> <p>Artists <b>MUST</b> be current SWS members at least 30 days prior to entry day.</p>
