Board Meeting Minutes January 14, 2023, 10 a.m. Reno Public Market, 2nd Floor, Reno

<u>Member Survey – Topic Challenges:</u> Graciela Mancini

To increase interest and participation in the General Meeting Painting Challenges, Graciela will solicit ideas and suggestions from members at today's general meeting. Apparently, some members may be intimidated by the "contest" part of the challenges.

Ruth Clark offered some historical information regarding the challenges. She shared that the original purpose was to encourage participation by all members, especially those who were not comfortable showing in the exhibits.

The group discussed some ideas to encourage more participation such as making the challenges more of a learning experience by providing anonymous critique and discussions of the methods used in the painting; and/or providing end of the year awards to members who participated most often.

<u>January 14, 2023, General Meeting Challenge</u>: "Splatter Watercolor Technique." Experiment with splatter painting using a flick of brush, toothbrush, eye dropper, spritz bottle over any background.

March 25 Challenge:

"Paint a white object."

For this challenge, pick any white object you like and experiment with different ways to depict it. Per our Challenge co-chairs, Graciela Mancini and James Gayles: "Since watercolor paper is usually white, it requires some tricks to give the illusion of volume to the object. A white flower, a white tablecloth, a white vase or cup. Anything that's white. You will find that when you paint it, there's color in the shadows and highlights." So, grab that white paper and start defining the subtleties of form, shape, values and WHITE!
