- Art Angels received \$3,000 from the Nevada Arts Council grant, with funds to be used for art supplies and volunteer travel expense reimbursement. SWS will be matching funds, with one contribution being the upcoming Art Angels auction and silent raffle, December 2nd through 9th.

- Ribbons were presented for the People's Choice awards from the Wilbur May Museum's "Seeds of Inspiration" exhibit. 1st place goes to Lynn Schmidt with "Coming Alive"; 2nd place was taken by Lisa Jefferson with "My Wild Mountain Rose"; and three paintings tied for 3rd place: Vicki Curwen's "Reflections, Monet's Garden", Sandra Hedicke Clark's "Ophelia", and Colleen Reynolds' "Eagle Valley Cottonwood".
- The Sparks Museum "A Summer Night's Dream" exhibit opened on August 10th with a total of 73 paintings that Tom Lynch is judging this morning. The landscape category is the largest with 32 submissions, followed by 15 florals, 11 "Fur-Fins-Feathers", 8 abstracts and 7 portraits. The reception will be held Saturday, September 21st, from 1-3pm, and the show will hang until Saturday, September 28th.
- The final 2019 exhibit will be at the Wilbur May Museum, chaired by Diane Sewell. Intake day is scheduled for Tuesday, November 12th. The theme will be "Something Old, Something New", with "new" being something created in the last two years.
